4 APPLICATION AGREEMENT

- Must operate a business phone that you can answer, and have a valid business license.

We reserve the right, at ANYTIME, to remove your status as an Authorized GBC Vendor, for any reason, and we agree to notify you of if this occurs so you may remedy the cause and so we can at our discretion can restore your status.

FEES

There are no required fees to list group buys or products.

OPTIONAL FEES

OTHER STUFF
